NATIONAL DO-NOT-CALL REGISTRY NOW AVAILABLE

THE FEDERAL TRADE COMMISSION HAS ESTABLISHED A NATIONAL DO-NOT-CALL REGISTRY FOR RESIDENTIAL CONSUMERS THAT DO NOT WISH TO RECEIVE COMMERCIAL SOLICITATION OVER THEIR TELEPHONE. THE NATIONAL REGISTRY WILL PRECLUDE TELEPHONE SOLICITATIONS MADE FOR COMMERCIAL PURPOSES ONLY, BUT WILL NOT PRECLUDE TELEPHONE SOLICITATIONS MADE BY POLITICAL ORGANIZATIONS, CHARITIES, TELEPHONE SURVEYORS, OR COMPANIES WITH WHOM CUSTOMERS HAVE AN EXISTING BUSINESS RELATIONSHIP WITHIN THE LAST 18 MONTHS OF REGISTRATION. YOU MAY REGISTER YOUR RESIDENTIAL TELEPHONE NUMBER(S) OR CELL PHONE NUMBER(S) BY CALLING THE TOLL FREE NUMBER, 1-888-382-1222 AND FOR TTY ACCESS, 1-866-290-4236.
